

Note.—The English compilation of the Annals of Ireland, commonly known by the "Annals of Clonmacnoise," was made by Conell McGeoghegan in 1627. The basis of it was an ancient chronicle in the Irish language, in part illegible through age and decay, which the compiler translated as far as he was able and incorporated with matter drawn from other sources. For an account of the compilation see O'Curry's Lectures, pp. 130-139. The present transcript is the oldest and most authoritative which is known to exist, and derives additional interest from being the copy which was used by the famous Irish scholar Roderick O'Flaherty, and which, by the marginal notes, bears evidence of the careful manner in which he studied and compared it. In many places he corrects the statements of the text, both as to chronology and names. This copy seems from footnotes of the scribe (at fol. 18b and 63b) to have been made in the early part of 1660. A hiatus between 778 and 905 (embracing six folios) has been supplied in a much later hand from probably a later copy. It was in the possession of Walter Harris, or at least was consulted by him, as his handwriting appears on the margin at patch of the first leaf. Afterwards it formed part of the great MS. collection of Michael I. Dugan; then became the property of the celebrated John Lodge and remained in his family till purchased with the remains of his MSS. for the Library from his great-grandson.

Note.—The papers contained in these three vols. consist for the most part of letters which passed between Dr. Anthony Dopping, Bp. of Meath, and his literary, clerical, and political friends. They came into the possession of Michael Ig. Dugan, a noted record collector, in the middle of the 18th cent., and passed from him to John Lodge, the celebrated archivist, from whom they descended to his son, the Rev. Dr. Wm. Lodge, the first Keeper of Armagh Public Library, then to his son, the Rev. Wm. Lodge of Killybegs, after whose death, on the sale of Ballinahone House, they were purchased with other manuscripts in June, 1865, for the Library, from his son, Wm. R. Lodge, Esq., being then tied up in bundles without any order, but subsequently arranged chronologically, and bound up in their present form by Dr. Wm. Reeves.


